## LIDS SAN ANTONIO MOSAIC SWEEPSTAKES

## OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. PROMOTION DESCRIPTION: The LIDS San Antonio Mosaic Sweepstakes ("Sweepstakes") is an online-only Sweepstakes. In this post, they must tag @lids and use the hashtag #LIDSmadness. Entrants are also able to add an @lids tag and #LidsMadness to previous posts on their Instagram account to use as an entry, however, these will only be counted as entries IF these tags are added during the promotional period and IF the photo meets all requirements. To be eligible to win, entrant must be following @Lids on the social network they post to. Limit one (1) entry per person, per email address, per social network, during in the Sweepstakes.
